

Browse hundreds of unique searchable online databases, offering more than 1.4 billion searchable names. Databases Include:

General Society of Mayflower Descendants Membership Applications, 1620-1920

The world's biggest searchable *Mayflower* database, featuring all applications and supplemental applications to the General Society of Mayflower Descendants (GSMD) starting from their founding in 1897. Created through a partnership with General Society of Mayflower Descendants (GSMD) and Family Search. Available to American Ancestors and GSDM members.

Mayflower Families Fifth Generation Descendants, 1700-1880

Known to genealogists as the "Silver Books," Mayflower Families Through Five Generations: Descendants of the Pilgrims who landed at Plymouth, Mass., December 1620 documents the descendants of the Pilgrims. Made possible through a partnership with GSMD.

Massachusetts: Roman Catholic Archdiocese of Boston Records, 1789-1920

Find millions of sacramental records from over 100 parishes across Eastern Massachusetts, the result of a multi-year collaboration with the Roman Catholic Archdiocese of Boston.

Published quarterly since 1847, The New England Historical and Genealogical Register is the flagship journal of American genealogy and the oldest journal in the field. Authoritative compiled genealogies have been the centerpiece of the Register for more than 150 years.

Early New England Families, 1641-1700

The Early New England Families Study Project provides accurate and concise published summaries of seventeenth-century New England families. Using Clarence Almon Torrey's bibliographic index of early New England marriages and its recent successors as a guide, the project focuses on individuals who immigrated from 1641 through 1700, grouped by year of marriage.

The Mayflower Descendant

Mayflower Descendant was first published by the Massachusetts Society of Mayflower Descendants in 1899. In 2015, New England Historic Genealogical Society assumed stewardship of the venerable journal. It is an essential source of information on many New England families, and its focus is not limited to those with Mayflower lineage.

Western Massachusetts Families in 1790

This database contains genealogical sketches of families enumerated in the 1790 census for Berkshire and Hampshire Counties (in what now also includes Franklin and Hampden Counties). Our database will be enlarged over time thanks to the submitted contribution of NEHGS members and staff.

The image-only version of our multi-year collaboration with the Roman Catholic Archdiocese of Boston to digitize sacramental records from over 100 parishes across Eastern Massachusetts. Available to view for free on our website—searchable records are available to American Ancestors members.

Vermont Genealogy made its debut as a quarterly journal in January 1996. In addition to featuring compiled genealogies, the journal often contains other material, including freeman's lists, church memberships and dismissals, newspaper vital record abstracts, probate abstracts, and more.
